This section provides background information about the population of Sheffield and surrounding areas to put into context the rest of the information provided in the Supplementary Information report.


1.1 About the population of Sheffield ¹

In 2011 a Census took place across the UK – the results were published in 2012 by the Office of National Statistics so we now have much better information about the population of Sheffield and the people who use and work in our organisation.

The Census suggests that on the 31st of March 2011 there were **552,698** people across all age ranges living in Sheffield.

1.2 The Age of the Sheffield population on the 31st of March 2011


Overall there are slightly more women (50.7%) in Sheffield than men (49.3%). The chart below indicates that in age groups up to mid-fifties there are slightly more men than women but in older age groups there are more women than men.





1.3 The Ethnicity of the Sheffield population on the 31st of March 2011

Nearly 81% of the Sheffield population describe themselves as White - English/Welsh/Scottish/Northern Irish/British. This is higher than the overall population in England but lower than the population of Yorkshire and the Humber.




Of the remaining 19% the highest alternative ethnicity reported in Sheffield is the Asian / Asian British Pakistani group (4%). The 2011 Census included two new groups 'gypsy and Irish traveller' and 'Arab'. The percentage of people in Sheffield who describe their ethnicity as Arab (1.5%) is higher than the percentage population in England and in Yorkshire and the Humber.




1.4 Languages Spoken In Sheffield on the 31st of March 2011

The Census suggested that only 9232 of the population on the 31st of March said they could not speak English or could not speak English well. The table below shows a breakdown in numbers of people and the main language used by the person, other than English, the table includes British Sign Language.



1.5 Religion of the Sheffield population on the 31st of March 2011

Just over 50% of Sheffield people stated in the Census they had a Christian religion, 31% no religion and 7.7% Muslim.



1.6 Sexual Orientation

Sexual Orientation was not recorded in the 2011 Census – the most up to date information about Sexual Orientation is found through the Office of National Statistic 'Household' Survey which estimated approximately 1.5% of the UK population are Gay/Lesbian or Bisexual.

1.7 Long-Term Health Problem or Disability of the Sheffield population on the 31st of March 2011

The Equality Act 2010 says a person has a disability if they have a physical or mental impairment that has a 'substantial' and 'long-term' negative effect on a person's ability to do normal daily activities.

The Census 2011 asks questions about a long-term (over 12 months) health problem or disability which limits the person's ability to undertake day to day activities, this includes activities limited due to health problems experienced due to older age. This is an indicator of the likely number of people in Sheffield who have a disability. The Census reported that;

- 9.1% of people said that their day-to-day activities were limited 'a lot' due long-term health problem or disability
- 9.6 % of people said that their day-to-day activities were limited 'a little' due long-term health problem or disability
- 81.2% said that their day-to-day activities were not limited due to a long-term health problem or disability.

Mental Health

The Sheffield Joint Strategic Needs Assessment Position Statement 2013² reports:

- Common mental health problems, such as depression and anxiety around 12.27% of Sheffield adults are estimated to have depression compared with 11.68% in England. Sheffield JSNA 2013 p.26
- Severe mental illness (such as psychosis or severe depression) the latest figures for Sheffield (2011-12) suggest that the number of people with a psychosis (all ages) registered with a Sheffield GP practice was approximately 4,500. When considered as a percentage of all people registered with a Sheffield GP, this represents 0.80% which is on a par with the England average of 0.82%. Sheffield JSNA 2013 p.26

Dementia

The Sheffield Joint Strategic Needs Assessment Position Statement 2013 reports:

There are currently around 6,400 people living with dementia in the City, but this is expected to rise to over 7,300 by 2020 and 9,300 by 2030, with the biggest increase in people aged 85 and over. Sheffield JSNA 2013 p.26

Learning Disability

The Sheffield Joint Strategic Needs Assessment Position Statement 2013 reports:

Sheffield has a higher prevalence of people with learning disabilities than the national average – this relates both to adults (18-64 years) where prevalence is 5.17 per 1,000 people registered with a GP compared with 4.33 nationally, and to children where 35.20 per 1,000 known to schools have a learning difficulty compared with 24.61 nationally – Sheffield JSNA 2013 p.26

People who are Deaf

The Health and Information Centre reports the number of people in Sheffield registered Deaf in Sheffield on the 31st of March 2010 was 990 people of all ages.³

People who are registered 'hard of hearing'

The Health and Information Centre reports the number of people in Sheffield registered as Hard of Hearing in Sheffield on the 31st of March 2010 550 people of all ages.⁴

People who are Blind

The Health and Information Centre reports the number of people of all ages.in Sheffield registered as Blind on the 31st of March 2011 was 1,725⁵

People who are Partially Sighted

The Health and Information Centre reports the number of people of all ages.in Sheffield registered as Partially Sighted in Sheffield on the 31st of March 2011 was **1,945**.⁶



Sexual Orientation was not recorded in the 2011 Census – the most up to date information about Sexual Orientation is found through the Office of National Statistic 'Household' Survey which estimated approximately 1.5% of the UK population are Gay/Lesbian or Bisexual.

Ethnicity

The reason for Arab ethnicity indicating 0% for trust workforce is that at present the national electronic staff record system (ESR) does not have a filed for Arab.

Disability

The number of staff indicating that they have a disability has increased from 4.4% to 5.6% and the number of unknowns has decreased.

Sexual Orientation

The information we have about the sexual orientation of staff in our organisation has continued to improve:

• Figures for 2014 show a positive increase in the number of staff declaring that they are Lesbian Gay or Bisexual rising from 1.90% on the 31st of March 2013 to 2.35 on the 31st of March 2014.

The number of staff who have not included this information on the electronic staff record has decreased which is also positive reducing from 32.30% in 2013 to 14.8% in 2014.


Religion or Belief

Disciplinary Procedures:

In 2012/13 we reviewed relevant cases concluded in 2012/13 and found that the reasons for bringing disciplinary action were associated with issues which are defined as serious or gross misconduct under the Trust disciplinary policy. In cases reviewed there had been no alternative intervention which would have been more appropriate or could have avoided the need for disciplinary action.

In 2013/14 a high percentage of cases of disciplinary action have again been taken against staff with Black Asian or other minority ethnicities. The Trust has again undertaken a review of these cases, the figures above relate to new cases commenced in the financial year 2013/14 therefore some are ongoing at the time of this report.

As was the case in 2012/13, out of the 11 cases in the table 79% were disciplinary cases which were for reasons that would be classed as gross misconduct under the Trust policy, if proved. The remaining 21% were legitimate cases under the disciplinary policy but not cases of gross misconduct.

A common factor identified was that of staff that are subject to disciplinary procedures, there is a higher percentage of staff in BME ethnicity groups as opposed to White British ethnicity groups that, in addition to their main post, also undertake work in the Trust through the flexible staffing service, this will be looked into in more detail in 2014/2015.

In 2013 we introduced a new system for reviewing pre disciplinary action and reported that we would give an update of this in this year's annual report. The first review of this monitoring has taken place and has already indicated some areas for action by the Trust which could be of benefit to all staff, for example use of the Trust capability procedures.






Use of Services by Age Learning Disability

3.4 Disability and People who use our Services

A large number of people who use our services will be defined as having a Disability under equality legislation, but many may have more than one type of disability. One of the Equality Objectives set by the Trust in April 2012 was to improve the information that we have about disabilities that service users may have. 


3.8 The Trust Gender Identity Service


People Using the Trust Gender Identity Service - Sex

People using the Gender Identity Service - Ethnicty









Sexual Orientation and Disability – Perinatal Mental Health









Eating Disorders Service - Age


Use of Interpreting Services

This table shows the use of interpreting services over the last five years and reflects changes in the demographics of people using Trust services.


Consistently the top two most requested languages are Arabic and Farsi.

There has been a steady increase in requests for Urdu and Slovak over the last five years.


In 2012/2013 there had been a notable decrease in requests for Bangla this has continued in 2013/14 and there has also been a drop in requests for Turkish.



Membership

Sheffield Health and Social Care is a Foundation Trust. Foundation Trusts are 'Public Benefit Corporations', because of this Foundation Trusts are accountable to local communities, they do this by having public and employee membership and a council of governors.
