Purpose:	The purpose of this report is to provide an annual update on the partnership between Sheffield Hospitals Charity (SHC) and Sheffield Health and Social Care NHS FT (SHSC), including an update on the balances of the funds held for SHSC.
Executive summary:	SHSC partners with Sheffield Hospitals Charity, a local NHS charity that supports our Trust and Sheffield Teaching Hospitals. In the last year we have worked on strengthening our collaboration and driving increased benefits for our service users and staff through this relationship. This report provides a summary of the actions and their impact and sets out the plans for the year ahead to continue in this direction.

Report title: Annual update: Sheffield Hospitals Charity (SHC)

1. Purpose of the report

The purpose of this report is to provide an annual update on the partnership between Sheffield Hospitals Charity (SHC) and Sheffield Health and Social Care NHS FT (SHSC), including an update on the balances of the restricted funds held for SHSC.

2. Background to Sheffield Hospitals Charity

Sheffield Hospitals Charity (SHC) exists to support SHSC and Sheffield Teaching Hospitals. The Charity's vision is "Every person cared for and working in our hospitals, community teams and health and social care services is treated with compassion and has access to the best equipment and treatments in the best environments." And its mission is "We help Sheffield's hospitals, community teams and health and social care services to cover the costs that the NHS can't. By funding support for patients and staff, life-changing research and more, we enhance care from birth to the end of life and everything in between."

SHC focuses its funding on four priorities which are closely aligned with the Trust's own priorities:

- Supporting patient centred experiences
- · Supporting caring and cared for staff
- · Reducing health inequalities in Sheffield
- Maximising technology, research and innovation

The key principle guiding SHC's grant making is that its funding should be additional to the core NHS funding provided to its beneficiary organisations, and the charitable funds cannot be used for items that should be covered by core NHS funding.

The Charity is led by a Chief Executive and a team of directors, and governance and oversight is provided by a board of trustees. SHSC is represented on the board of trustees by the Director of Strategy who has become a trustee director of the Charity this year.

3. Relationship with SHSC

Relationship management is led by the Director of Strategy, James Drury and Executive Assistant, Helen Walsh. Several other Trust employees are actively engaged in supporting the relationship with the Charity including the Communications, Finance and Procurement teams.

Activities undertaken to develop and maintain the relationship include:

 Webinars and internal communications campaigns to encourage SHSC staff to make good quality bids for charitable funds.

- Reminders to budget managers of services with restricted funds to encourage the use of charitable funds.
- Promotion of strategic 'funding calls' to generate bigger Trust-wide bids. For example, the recent 'caring and cared for staff' funding call received several significant bids curated by the People Directorate aligned to our workforce wellbeing agenda.
- Improved clarity of internal trust processes associated with making charitable bids and utilising funding.
- Frequent liaison with SHC to support SHSC colleagues to make high quality proposals.
- Liaison with SHC in respect of fundraising campaigns.
- Liaison with SHC to ensure grant holders provide an evaluation of their successful bid.
 This may involve SHSC Communications Team taking photographs (before, during and after).
- Showcasing the Trust's activities to SHC and advising SHC to shape their funding calls. For example, in relation to women's health inequalities, dementia, and staff wellbeing.

4. The funds

Sheffield Hospitals Charity holds charitable funds of considerable value. Some of these are unrestricted and can be used to support any of the charities aims in accordance with its strategic priorities. Other funds are restricted and can only be used by a particular Trust or service.

The restricted funds held for the benefit of SHSC at the end of Q4 2024/25 are:

6. Fundraising activities

In 2024/25 SHSC staff have taken part in activities to raise funds for SHC, much of which has been directed into the restricted funds above:

 SHSC colleagues undertook a <u>'Charathon'</u> around the Michael Carlisle Centre in December. Organised by the Communications team this event raised £500 which was directed towards the purchase of gym equipment for the use of service users at the Beech rehabilitation facility. SHSC colleagues took part in '62K in October' which was part of SHC's annual programme of events, raising £150 for SHC general funds and promoting engagement with the Charity across the Trust.



7. The year ahead

- a. In addition to the grants listed above, in the last year SHSC and SHC have worked together on several strategic funding initiatives which are expected to yield results in 2025/26. These include:
 - Support for the Maple Ward refurbishment which will (subject to confirmation in June 2025) enable touch screen entertainment, communication and information systems in each bedroom, and an autism-friendly sensory de-escalation room.
 - Staff wellbeing. The Trust was successful in gaining support from SHC for four projects that will supplement our existing workforce wellbeing programme, which is part of our Great Place to Work strategic aim. The four projects are:
 - Development Days for Wellbeing Champions and establishment of local on-site Wellbeing Hubs for staff
 - Digital Inclusion & Empowerment Initiative: a peer-led and experts by experience approach to support staff who are digitally excluded
 - Health Coaching to facilitate the return to work after long-term sickness
 - 'In Reach', a pilot of tailored support for staff who are absent due to stress, anxiety and depression
 - Women's Health inequalities including perinatal mental health
- b. SHC will have several time-limited strategic funding calls throughout the year. We will encourage colleagues to make high quality bids for these opportunities. The next one will open in June and will be focused on Reducing Health Inequalities.
- c. Webinars for SHSC staff will continue throughout the year in order to promote the availability of charitable funds and how to apply for funding.
- d. Fundraising will continue throughout the year in conjunction with SHC and our Communications Team.
